Bird Tech Talk

"I'm having trouble finding a battery for my T-Bird."

Batteries for our Classic 1955-57 T-Birds are becoming more expensive, and some types are difficult to find. Below is a summary of available batteries for each T-Bird year.

1955 - The '55 T-Bird uses a 6-volt group 2N battery which measures 10x5.5x8.75. This battery is no longer produced by the major manufacturers and is only available as a reproduction original using AGM (absorbent glass mat) technology, which does not use liquid acid. The sole producer is Jim's

Manufacturing in Ohio, sold by Battery Central Mall in Virginia. The battery costs nearly \$400, and there is a minimum of 4-6 weeks or longer wait. Google batterycentralmall.com for details. A group 2 battery (left photo) is available from most stores, but it is too wide and slightly longer for the battery tray and hold down. The AGM Optima-6V #9010-044 fits the battery tray but is very narrow, and one would have to fabricate a hold-down. The battery top is also red, and the case has a modern design (right photo).

For a 1955 with a 12-volt conversion the Group 56 battery fits the tray well if one cuts away the hold down rails on the lower edges. Most

auto parts stores carry these batteries but are also getting harder to find and are near or higher than \$200. A Group 51 battery will also work, but it is narrower and slightly shorter than the original, and the hold-down will be too large.

1956-1957- These cars use a Group 29NF 12-volt battery or a heavy-duty Group 32 battery. A similar battery tray is used for both types of batteries, but a different hold-down is used for Group 29NF and Group 32. The Group 29NF is available from the usual stores such as NAPA, Interstate Battery, and various auto parts stores (right photo) but may not be on the shelf and may need to be ordered. Group 50 is close in size to the Group 29NF. The AGM reproduction group 29NF can also be ordered from Battery Central Mall. The Group 32 is unavailable from any source except as an original reproduction AGM battery from Battery Central Mall at over \$400 for it and the 29NF and a long wait.

The bottom line is that T-Bird batteries are becoming more expensive, and the 1955 6-volt battery choices are very limited. All T-Bird batteries are positioned in the battery tray with the positive post forward. Finally, check that the battery posts do not hit the hood if one uses a non-original battery that does not fit the tray.









CTCI UPDATES



CTCI Board Meeting Highlights March 15, 2024

President Chuck Thompson discussed committee assignments. He explained that the membership committee will have the most members because its recommendations will impact the size of CTCI. The Committees for 2024 will be:

Executive, Investment, Nominating, Membership, Web Site

Treasurer's Report: John Kledis presented the Treasurer's report. This report was for the entire year of 2023 and will be the basis of the US Treasury 990 filing. On the Balance Sheet, CTCI showed "Club Equity" of \$1,320,526, slightly higher than the previous year. The Revenue and Expenses sheet showed that both revenue and expenses were up from the prior year. The Club's functional loss was under \$10,000. This is close to 2022 and significantly better than planned. John also explained that we should eliminate any loss in 2024 with the dues increase. Finally, John reported that we had a significant increase from the prior year in Other Income. Thus, the club is showing a year-end net income gain of \$62,948, a significant improvement over 2022's loss. Most of this gain is due to changes in the cash-cost basis of the CTCI Investment Fund and is made up of previous year's losses.

2024 Convention Update: Brian Carron presented the status of the 2024 International Convention. The International Convention will be held in Des Moines, IA, from August 20 through August 25, 2024. It was noted that the contracts for the hotel, transportation, and entertainment for the Welcome Party have been completed. The Welcome Party has been moved to a location near the hotel instead of the hotel as a cost-saving move. Also, Brian noted that the group is starting to receive some sponsorships. Brian reported that Bob Young and Marsha Hash are working on all the events. These include viewing car collections and other tours that will interest the





members. Current plans are for the registration forms to be completed and online before the end of March. Finally, it was reported that there would be a "Swap Meet," a General Membership Meeting, and a CTCI Board Meeting. Meanwhile, we wish to remind all members that hotel registration is open. Please see the CTCI website or The Early Bird to get the link for Hotel Reservations. Please register early to hold your place at the 2024 Convention Hotel.

Member Renewals: Garrett presented membership renewals through February 2024. We ended the year with 4,015 members and added 218 new members. During January and February, we gained 24 New Members. We have not converted any new members from the Test Drive Program. He reported that we are well into the 2024 Membership drive. To date, we have only received 38 notices of dropouts. Garrett outlined that we are ahead in the member renewal process. At this point, we still have 998 members pending renewal. This is not an unexpected number based on past history and is better than the same time last year when we were short 1,044. Also noted is that the Jan-Feb issue was the last issue sent to 2023 members who have NOT renewed for 2024.

Garrett also made a recommendation about adding a marketing plan that will be forwarded to the Membership Committee. With the By-Law change, CTCI needs to market directly to both '55-'57 and '02-'05 T-Bird owners. This is especially true for the Modern Classic—Retro owners, who, up to this point, have not thought that CTCI wanted them.

Office Activity: Garrett presented the Office Activity Report. He noted that the office was spending the bulk of its effort on the member renewal process. In addition to the time assisting the Treasurer with year-end reporting, the office is working on updating the "New Member" packets. Also, the Office is working with the 2024 Convention Committee to provide support for contracts and bookkeeping.

2023 Convention: Brian Carron reported to the Board on the CTCI Awards related to the Concours judging at the 2023 Regional Convention. New plaques have been created for Gold Mediation, Excellence in Authenticity, and Preservation Award (separate from recognition awards already presented). Those plaques have been completed and will be sent out to individual award winners in the next week.

Investment Committee: President Chuck Thompson announced that Bill Phelps and Gaylan Abood are moving off the Investment Committee. He thanked both for their service and assistance during their time as initial committee members. Chuck also announced the addition of Jim Cook to the Investment Committee. Jim was previously on the Committee and agreed to rejoin the group.

In a related announcement, Chuck reported that, based upon the investment committee recommendation and CTCI Board approval, the relationship with Meritage (as investment broker) has been terminated. Also following that recommendation, going forward the CTCI Investment would be "self-managed", with trades being directed by the Investment





Committee. Garrett Shropshire was asked to provide a "conservative fixed income" investment recommendation to the investment committee.

2025 Convention: Chuck Thompson presented the need for a Chapter to sponsor the 2025 Regional Convention. While some chapters have expressed an interest in sponsoring a convention, up to this point no Chapter has presented a formal proposal. Any chapters who wish to sponsor a Regional Convention in 2025 should reach out to Chuck. Please note, to allow proper planning time, interested Chapters should let Chuck know before August 1.

Director Election: Chuck Thompson reminded all members of the upcoming Director election that will be held later this year. The election will cover Regions 2, 4, 6, and a Director-at-Large position. Each interested member should think about creating a bio. Per the CTCI Bylaws, Candidate bios have to be received by the CTCI office prior to August 1, 2024, and will be published in the September-October Issue of The Early Bird. If you have any interest, please see your Regional Director or contact Chuck for details.

Newsletter Contest: Marsha Hash wanted to remind all members of the Newsletter Contest. Each chapter newsletter editor is encouraged to submit their newsletter for judging. Editors are requested to select their single best issue from January 1, 2024, to September 1, 2024, and email or mail 5 copies of that one issue to Marsha Hash. Newsletter Editors can read more about the contest online or in the May-June issue of The Early Bird.

Thunderbird Appreciation Day: Chuck Thompson also wanted to remind all members of Thunderbird Appreciation Day. This year it will be held on May 19th. He encouraged all members to contact their local club to find activities in their area. Most importantly he asked all members to get out and enjoy celebrating with other T-Bird enthusiasts.

Short Term Membership: A suggestion was made and approved by the CTCI board to allow non-members who wished to sell their Thunderbird a method to accomplish that. The Board approved a "short term member" plan to allow 60-day membership and thus allows the "short term member" to be able to pay and place a classified notice about an available Thunderbird. This will help our current members since it would allow our CTCI members the "first look" at available Thunderbirds as well as additional marketing opportunities to the car buyer.

Co-Branding: Brian Caron and Bob Bly discussed their upcoming meeting with the other three Thunderbird organizations (VTCI, ITC, and Thunderbird Nest). This meeting will be used to discuss areas where the organizations might work together cooperatively, including some possible co-branded events.

Member Comments: As with every Board meeting, the Board reviewed all member comments about CTCI operations submitted over the past two months. Most of these were related to the CTCI website. Chuck plans to have the Website Committee meet to





discuss these in detail and develop recommendations to improve. The next Board meeting is set for May 17, 2024.


